

### Set up the Camera Using a Smartphone


Step 1 Scan to download the Reolink App from the App Store or Google Play store.








Step 2 Press and hold the power switch for two seconds to power on the camera.



**Step 3** Launch the Reolink App, click the " button in the top right corner to add the camera. Scan the QR code on the device and follow the onscreen instructions to finish initial setup.

NOTE: This product has two QR codes, one on the back of the machine and one on the bottom of the machine.

When you have installed the machine, if you need to configure the device again, you can scan the QR code on the bottom of the device.




**Step 4** In the "Add Device" page, configure the Wi-Fi connection by enabling Bluetooth on your phone and follow the onscreen instructions to finish the initial setup.

# **Charge the Camera**

It's recommended to fully charge the camera before installing it.

#### **Charging Indicator:**

• Orange LED: Charging



Charge the camera with a 5V power adapter (not included).



• Green LED: Fully charged

Charge the camera with the Reolink Solar Panel (not included if you only purchase the camera). For details about the installation of Reolink Solar Panel, see its Operational Instruction.




For better weatherproof performance, please always cover the charging port with the rubber plug after charging the camera.

### Install the Camera


Install the camera in residential areas with faint ambient lighting at night or wild areas with moonlight or starlight, so it can deliver true full-color night vision. Even in extreme darkness with no light source, the camera will turn on its spotlights for extra lighting.

- Install the camera 2-3 meters (7-10 ft) above the ground. This height maximizes the detection range of the PIR motion sensor.
- For better motion detection performance, please install the camera angularly.




NOTE: Make sure the side-to-side movement crosses the camera's field of view. If a moving object approaches the PIR sensor vertically, the camera may fail to detect motion.

### Ceiling or Wall Mounting Camera






Ceiling Mounting Camera

Drill holes according to the installation template.

Drive 4 long screws into the drill holes. If it is a hard wall, please drive the wall anchor into the drill hole first, and then tighten the long screws.




Install the camera onto the mounting base.



To secure the camera, drill the two short screws into the corresponding holes on the mounting base and the side of the camera.

Thread the provided straps onto the board and secure it to the tree as shown below.

# **Troubleshooting**

### Camera is not Powering on

If your camera is not powering on. please apply the following solutions:

- Make sure the power switch is turned on.
- Charge the battery with a DC 5V/2A power adapter. When the green light is on, the battery is fully charged.

### Failed to Scan the OR Code on the Phone

If the camera cannot scan the OR code on uour phone, please tru the following solutions:

- Remove the protective film from the camera lens
- Wipe the camera lens with a dru paper/towel/tissue.
- Vary the distance between your camera and the mobile phone so that the camera can focus better.

• Tru to scan the OR code under sufficient liahtina.
